Ideas and feedback for moving forward with 2011 Nisqually Watershed Stewardship Plan:

Create "State of the Watershed Report"

- Create a regular update on State of the Watershed Report
 - Establish working sub-committee
 - o Goal: 1st report by March 2018
 - o Include monthly updates on indicators at each NRC meeting
 - o NWSP priorities and NRC/NRF priorities... 2 foci
- Successes and deficits
- To give an overview of goals and status... could draw from existing reports [Pierce County Report Card, etc.]
- Would create increased interest in community on what is currently happening
- Identify indicators (trails, farmers market, etc.), and work with others to collect data on indicators
- Report on successes/challenges for associated programs and capture lessons learned (i.e. Nisqually Sustainable)
- Stronger in environmental indicators (vs. economic, social)
- Economic indicators
 - o Gravel mining, asphalt recycling
 - o Getting tribal input on county process
 - Groundwater concerns
- Current strength and focus = rivers/streams
- Missing climate change resiliency
- Missing indicator: Pesticide and fertilizer use, awareness, impacts on food, children, bees

Economic Development

- Helpful to find funding or create guiding framework
- Economic and environment indicators shaped together and identified (NRC, Yelm and others) Outreach to other communities Start with Yelm to develop model
- How can NRC support efforts of jurisdictions?
- Could help define/identify NRC next steps
- Diversify NRC? Focus on Enviro? Hiring Expertise? Attracting business and industry that are in line with NWSP
- Form committees for each NWSP Focus (Environment, Social, Economic)
 - o 1st subcommittee: using Yelm as Model
- 2009-11 West Rainier Economic Development Initiative

Endangered Species/Plants

- How to report? Need pictures and GPS coordinates to send to UW
- More evidence to protect lands
- Can we do NatureMapping of endangered plants?
- Inventory endangered plants in watershed?
- Bioblitz with NWTrek?
- Ohop has been done previously 10 year NatureMapping
 - o Citizen science "wing" of CAC and NSS to collect and report on several key indicators for State of Watershed report? Would inform planning.
 - o Ohop NM data before and after restoration is impressive
- Citizen science Nisqually program create a subcommittee? Reformat Stream Stewards?)
 - Track restoration
 - Goal based

Where are we heading?

- Will NRC/NRF implement NWSP? Or will NRF recruit and report back from other partners?
- Past: Delta, Ohop restorations, Land acquisition
- Future: New Salmon Recovery plan by 10/2/17
 - o Late fall early winter: Chris Ellings will do an NRC presentation
 - o Nisqually Indian Tribe's 2017 ranked list for NRC Approval
 - o 7 projects, see picture
 - o 3-5 do not need capital budget \$
 - o What is 'success'?
 - DC folks see de-listing as success. No fish species has been delisted. Hood Canal Summer Chum has best chance for being delisted.

NRC Youth Council
